Composition:

Manganese sulfate, cobalt sulfate, copper sulfate, phosphorous acid, amino acid, carboxylic acids, anionic surfactant, emulsifier, water, and EDTA.

General Information:

Fulltec Ultra is a nutritional and plant health package that aids in lowering the damage caused by white mold (*sclerotinia spp.*) and prevent glyphosate induced manganese deficiency.

FIRST AID:

If in eyes: Immediately flush eyes with clean water for at least 15 minutes. If irritation persists, seek medical attention.

Prior to use, read all directions in this label. User should consult a trained agronomist or a certified crop advisor for specific recommendations. This product is for use in a balanced program for the crops listed in the label.

Rates

Timing	Rate of Fulltec Ultra
V3-R1	4.0 - 5.5 oz/acre

For white mold, the first application should be at R1 (early bloom) and second application 14 days later.

SHAKE WELL BEFORE USING.

Crops:

Apples, Beans, Berries, Cereals/Small Grains, Citrus, Corn, Cotton, Curcubits, Grapes, Nursery Crops, Nut Crops, Ornamentals, Peanuts, Potatoes, Pulse Crops, Rice, Sod/Turf, Soybeans, Sugar Beets, Sunflower, Vegetable Crops, Wheat.

Compatibility:

This product can be used/mixed with pesticides, but a "jar compatibility" test should be conducted for unfamiliar mixes in order to determine compatibility.

Mixing:

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Fulltec Ultra

2. Dry formulations (WP, DF, WDG, SP), and AMS
3. Flowable formulations (F & FL), liquid concentrates or suspensions (LC, ME, SC, CS)
4. Emulsifiable concentrates (E, EL or EC)
5. Solutions and soluble liquids (S or SL)
6. Liquid micronutrients and fertilizers
7. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
8. Finish filling to desired spray volume level and continue agitation.
